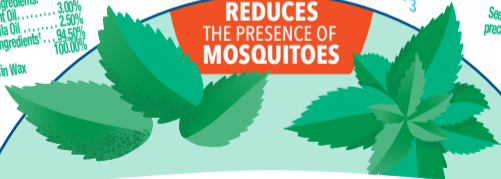

**STOP. READ ENTIRE LABEL BEFORE USE. FOR OUTDOOR USE ONLY.**

**WHERE TO BURN:** OUTDOORS, not in enclosed areas, to avoid concentration of soot, smoke or scent. **DO NOT** burn indoors. Burn on a stable, level, heat-resistant surface. For best results, use at least three candles spaced around the perimeter of the outdoor area where people will gather.

**BEFORE LIGHTING:** Keep wick trimmed to ¼ inch or less at all times to reduce sooting. Remove any foreign material or liquid from container. Do not use if container is chipped or cracked.

**WHILE BURNING:** **▲ WARNING** • Burn within sight. **DO NOT** leave unattended. • Keep away from things that catch fire. • Keep away from children and pets.

**AVOID FLARE-UPS:** • Never put anything that can burn in the candle. • Keep candle away from external heat sources. • Do not use water to extinguish candle – liquids can expand the flames or splatter wax. • Do not burn for more than four hours at a time. • Discontinue use when ¼ inch of wax remains. • Cover when not in use to protect candle from water and debris.

**BEFORE MOVING:** Extinguish with lid and let wax harden. Never pick up or move a burning candle.

**PRECAUTIONARY STATEMENTS • Hazards to Humans and Domestic Animals • CAUTION.** Avoid contact with skin. Not following instructions may lead to fire hazard or personal injury.

**FIRST AID • If on Skin:** Wash with plenty of water. If skin irritation or rash occurs, get medical advice. Wash contaminated clothing before reuse.
